

## Summary of Fall Public Meetings for Program Year 47 (2021-22) Housing and Community Development Consolidated Plan

### Overview

Due to the Coronavirus (COVID-19) pandemic, the Mayor of Los Angeles had imposed social distancing safety measures by cancelling public meetings on March 12, 2020. Because virtual meetings are a safe and effective way to reach many persons as it affords the public the convenience of staying home while receiving valuable information regarding their communities, virtual public webinars were used for public participation and input for the 47<sup>th</sup> Program Year (PY 47) 2021-22 Housing and Community Development Consolidated Plan (Con Plan). There were two virtual public meetings utilizing GoToWebinar. An English language virtual meeting was held on October 20, 2020, and a Spanish language virtual meeting was held on October 21, 2020, to allow for greater participation by non- and limited-English speaking persons. Both meetings were held in the evening from 6:00 pm to 7:00 pm. There was a total of 100 registrants and 57 attendees for both virtual meetings, with 37 attendees at the English meeting and 20 at the Spanish meeting. In addition to the virtual public meetings, there were two virtual consultation meetings provided through commission hearings which included public participation.

### Outreach

HCID used a number of outreach methods to promote the virtual meetings, including: flyers, mass email notification to about 25,000 subscribers, posting on the HCIDLA website and social media outlets, newspaper publication, the City's Channel 35 television station, the Los Angeles County Commission on HIV website, as well as notifications to the Mayor's office, Council Districts, Commissioners on several commissions, Neighborhood Councils, community-based organizations, and other City departments.

### Virtual Public Meetings (Webinars)

The virtual public meetings included a presentation on what the Con Plan is; the Con Plan goals; examples of the programs and projects that have been funded; how funding was budgeted for the current year; the estimated grant funding for PY 47; and the additional CARES Act funding and its proposed uses to assist Angelenos during the COVID-19 pandemic.

Additionally, there were presentations on Affordable Housing and Homeless Programs and Services to inform the public on how the City of Los Angeles is addressing these concerns. The Affordable Housing presentation explained the usage of primarily

HOME grant funds with other funds (including the local Proposition HHH) to finance new construction and rehabilitations of multi-family rental housing for seniors, persons of special needs, low-income and homeless persons. Information was given on how to access and apply for affordable housing.

The Homeless Programs and Services presentation provided statistics of the homeless populations in the City of Los Angeles and L.A. County. The information presented also discussed how HCIDLA works with the Los Angeles Homeless Services Authority to administer CDBG and ESG grant funds to address homelessness. Additionally, information was provided on other homeless assistance funding sources, and the accomplishments on how many persons have been housed and assisted.

### **Public Participation**

Throughout the presentation, the audience participated through answering interactive poll questions, submitting comments and questions, and responding to a survey question at the close of the meetings. Questions and comments were addressed live during the final part of the meetings. Opportunities for continued participation were provided, including: email to submit more comments and questions, website information, and how to subscribe to the newsletter to receive updates on the Con Plan. The MyLA311 website, app and phone number were provided, as well as the website on accessible and affordable housing in Los Angeles, to assist attendees with information on other City resources.

The interactive poll questions were: 1) Is this your first time attending a Consolidated Plan public meeting; 2) Of the four federal grants mentioned, which one does the City of Los Angeles receive the most money for? Choose one answer; 3) Now that you have heard our goals and seen examples, what is most important to you? Pick your top 3 only; 4) How are, or were you most impacted by COVID-19; 5) If given the opportunity today, how or where would you spend the money? Choose only your top 3; 6) How did you hear about the meeting; and 7) Would you come to future Consolidated Plan meetings, and tell others?

A survey sent after the meetings ended asked the participants to provide their zip code, and of the total 57 attendees, 25 responded. Most of the participants' zip codes represented Central Los Angeles close to the Downtown area. One response from the Spanish meeting represented the City of Bell outside of the City of Los Angeles.

### **Poll Questions Trends & Highlights**

Most of the poll questions were answered similarly by participants in both meetings. The trend from Q1 indicated that this was the first time attendees had attended a Con Plan meeting.

There were some key contrasts in the responses from the English meeting as compared to the Spanish meeting. When asked in Q3, of the Con Plan goals presented, what was most important and to choose their top three, both meetings' participants chose: to

develop affordable housing, and to help low to moderate income family to stabilize economically. There was a difference in the last choice of their three top answers. The English meeting participants responded: to prevent and reduce homelessness/domestic violence. Whereas, the Spanish meeting participants responded: to improve the local economy for low-income residents. When asked in Q4, how are or were you most impacted by COVID-19, the English meeting attendees responded having feelings of loneliness or health concerns, while the Spanish meeting attendees responded having experienced loss of employment was their greatest impact. When asked in Q5, how or where would they spend the money, and to provide their top three choices, both the English and Spanish meeting participants selected: social services/help people recover from the COVID-19 recession, and economic opportunities. In contrast, the last choice of their top three on how they would spend the money differed. The English meeting participants chose affordable housing, and the Spanish meeting participants chose neighborhood facilities.

From the English meeting, for Q6, respondents expressed they heard of the meeting through a community organizer, or a friend or colleague, and for Q7, 100% of the respondents expressed they would come to future Con Plan meetings and tell others. Answers to Q6 and Q7 from the Spanish meeting are not available due to technical difficulty.

The effects of the current COVID-19 pandemic are shown by the responses that indicate that most participants would spend the funds on social services/to help people recover from the COVID-19 recession, and that many participants were impacted by loss of employment and/or felt loneliness or experienced health concerns. This is in contrast to responses obtained prior to the pandemic. Last year, when asked what was most important, and how or where would they spend the money, most responded that their priority was to develop or preserve affordable housing. While the need for affordable housing is still great, the current COVID-19 pandemic and resulting recession has led to other concerns and priorities.

The poll questions and survey question responses are provided on Attachments 2 and 3.

## **Challenges**

Holding public meetings through virtual technology for the first time resulted in a few challenges. There were a total of 248 persons who clicked the link to register for the virtual meetings, however 60% did not complete the registration, which negatively affected the attendance. Additionally, miscommunication about the start time for the meetings resulted in many registrants leaving both meetings before they started. Furthermore, a technical glitch at the October 21<sup>st</sup> meeting resulted in not being able to present and obtain answers on all of the poll questions.

**Consultation Meetings**

In addition to the two virtual public meetings, there were two consultation meetings held that also allowed for public participation. The Los Angeles County Commission on HIV Planning, Priorities & Allocations Committee virtual meeting was held on October 20, 2020, from 1:00 pm to 3:30 pm. This meeting was attended by 28 participants, including 13 members of the public. The Commission on Community and Family Services was held on November 2, 2020, from 9:30 am to 11:30 am. There was a total of 25 participants, with 12 members of the public.

The Con Plan was presented similarly to the virtual public meetings, except that the Affordable Housing and Homeless Programs presentations were not included. The Commissioners' questions were addressed live during these meetings, and that information is provided as Attachment 5. There were no comments from the public during these meetings.

**Email Comments**

There were three public comments received by email, which are included as Attachment 6. These comments discussed domestic violence and homelessness, which align with concerns shared in other public comments, as well as virtual learning challenges and COVID-19 testing locations, which are additional concerns.

**Conclusion**

With the new normal of social distancing from the current COVID-19 pandemic, we have embarked on learning new ways of communication, including virtual meetings. With this method, the Con Plan reached a new audience, as this was the first time 83% of the participants attended a Con Plan meeting. The new technology also resulted in some limitations in connecting with the public, indicating a need to research other ways to address and overcome them, should the virtual means become the new standard. Overall, there was meaningful feedback from the participating public, and many participants appreciated the information and gave positive remarks on the presentations given.

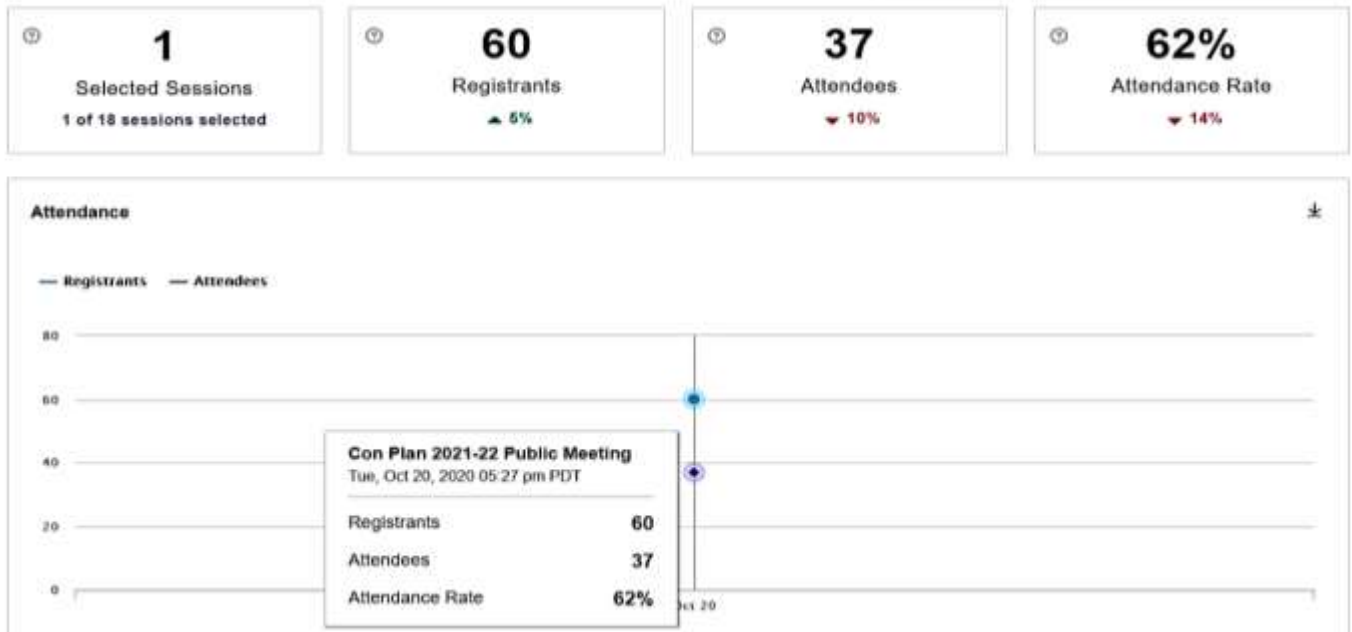

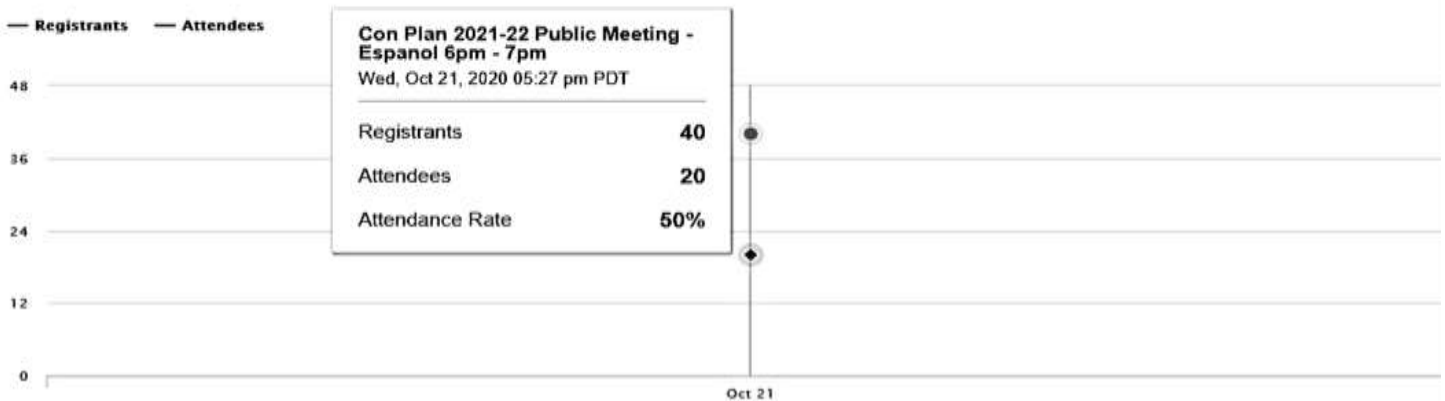

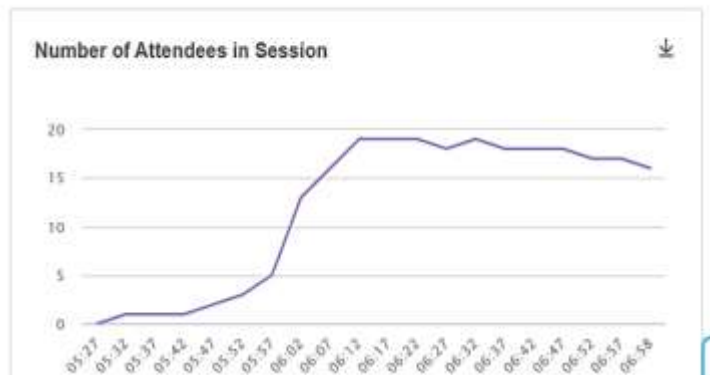

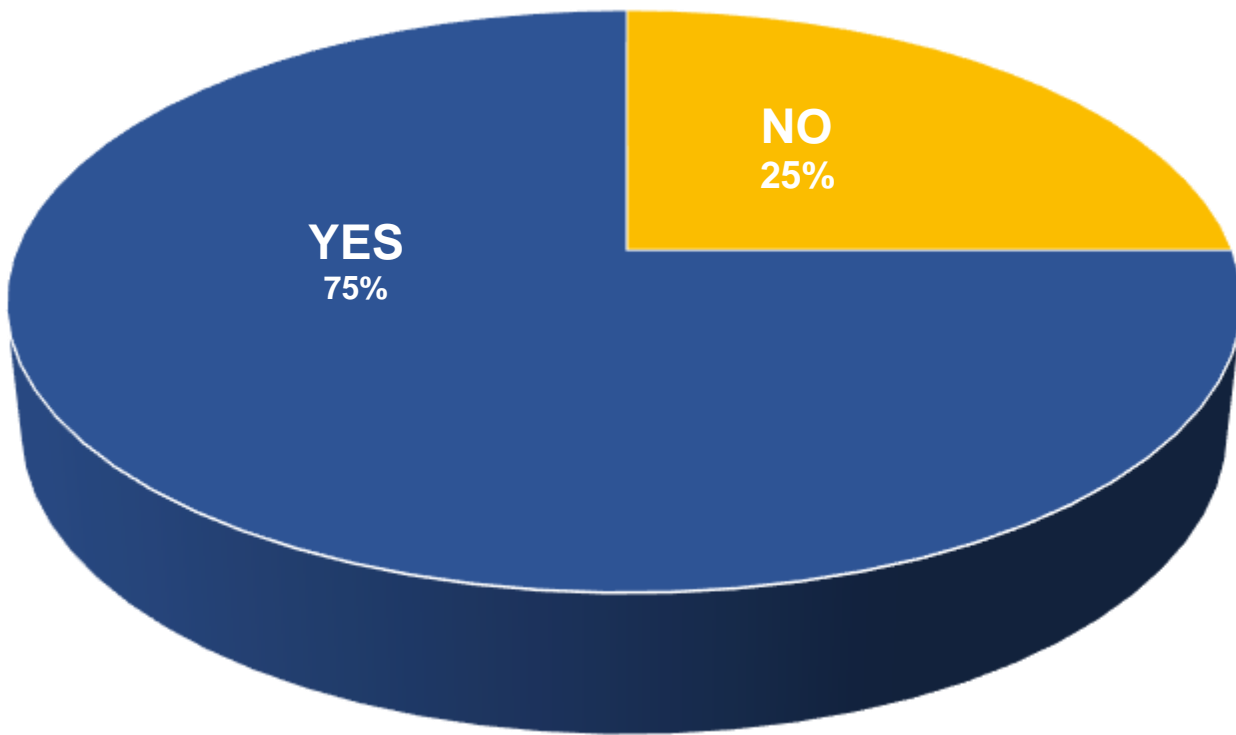

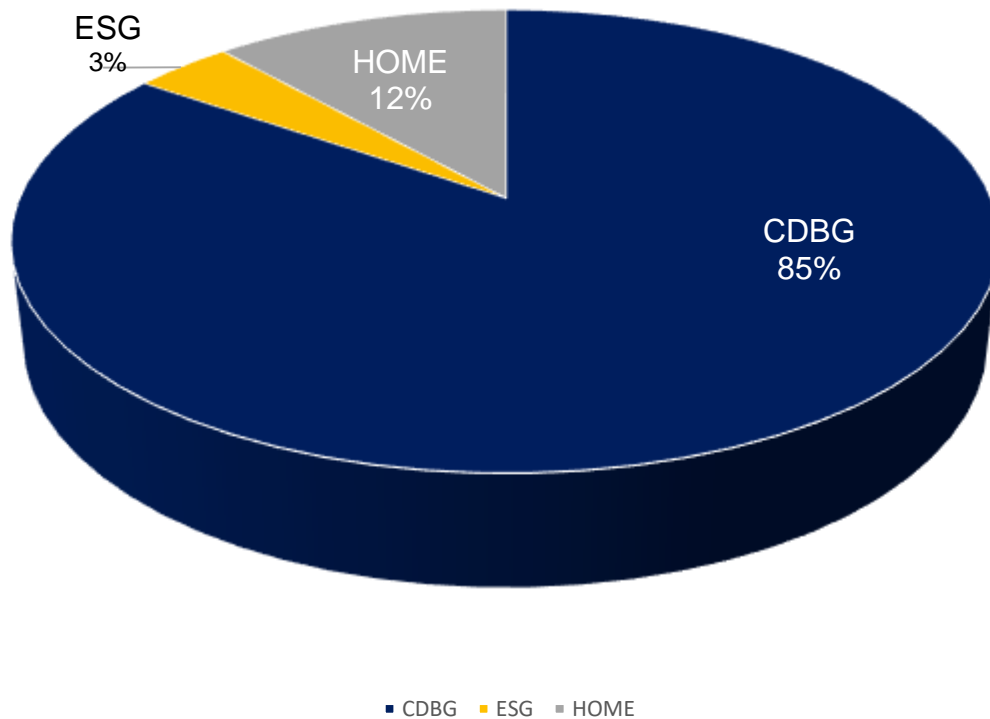
Audience Engagement on October 20, 2020

1. Is this your first time attending a Consolidated Plan meeting?



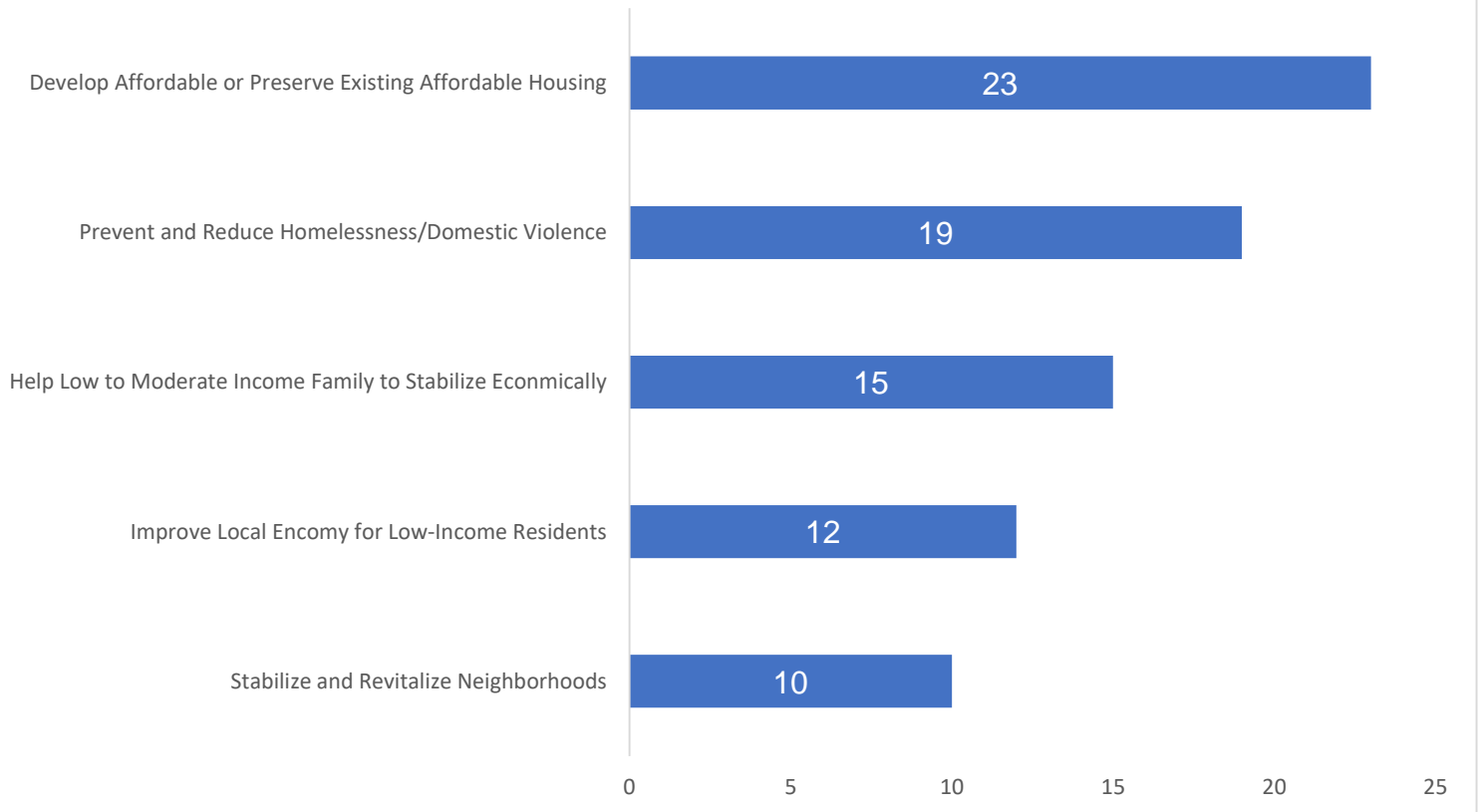
There were 24 responses out of 37 respondents, and 75% of those respondents attended the Consolidated Plan meeting for the first time.

Pick your top three only

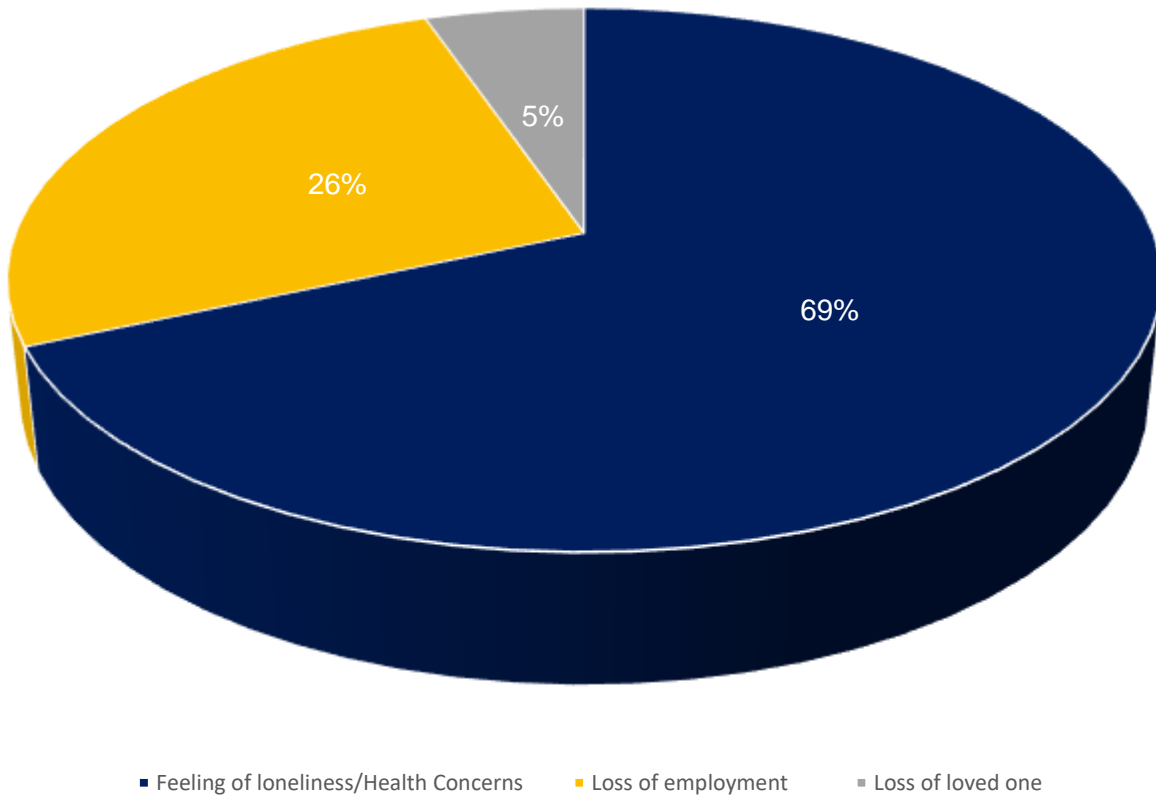


The top 3 most important goals chosen were:

- Help Low to Moderate Income Family to Stabilize Economically at 41%

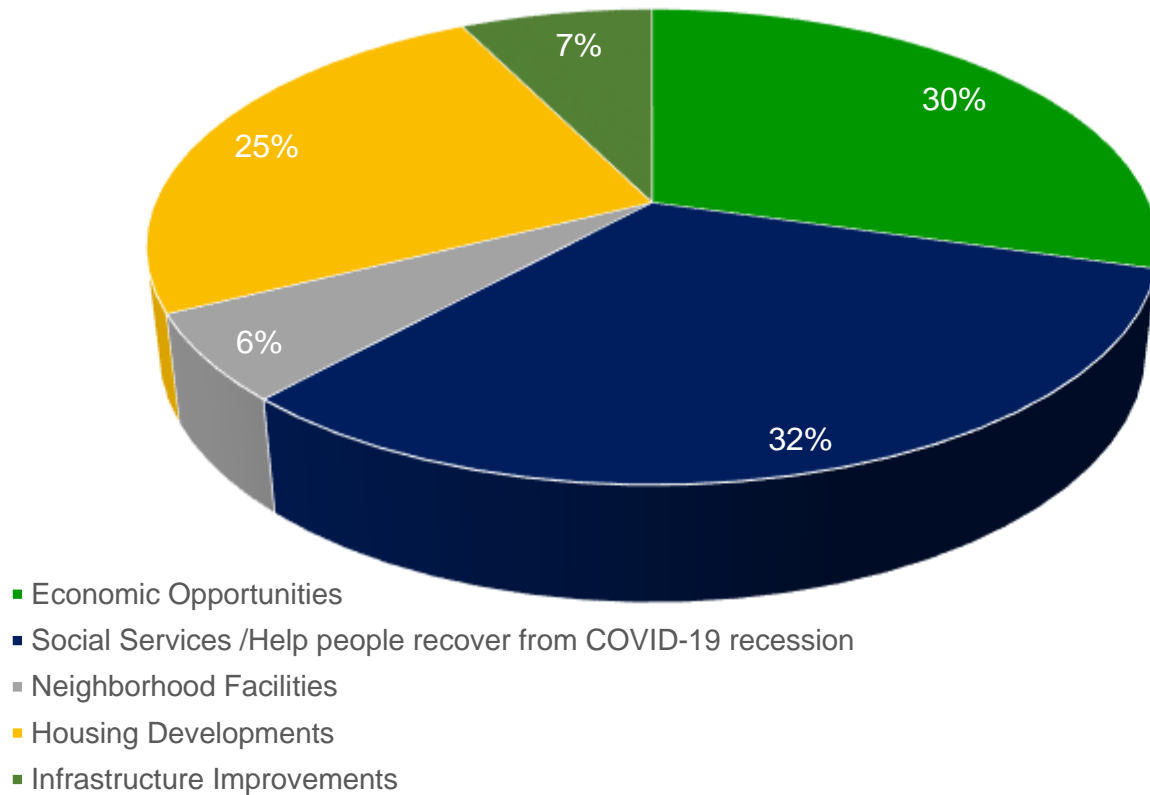

Choose only your top 3

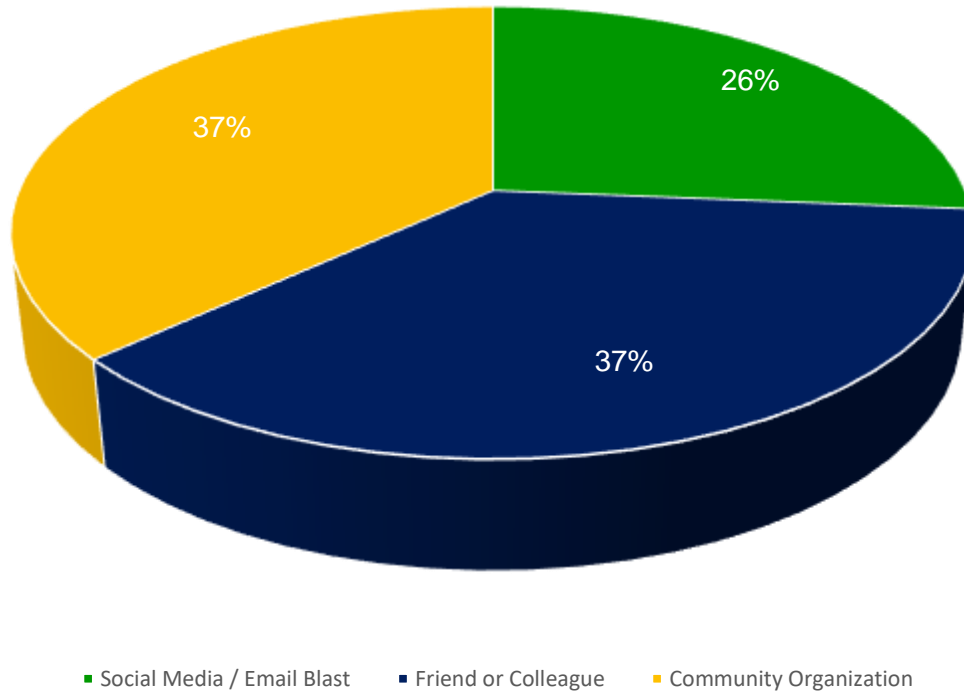


The top 3 chosen opportunities on how money would be spent were:

- Housing Developments at 25%

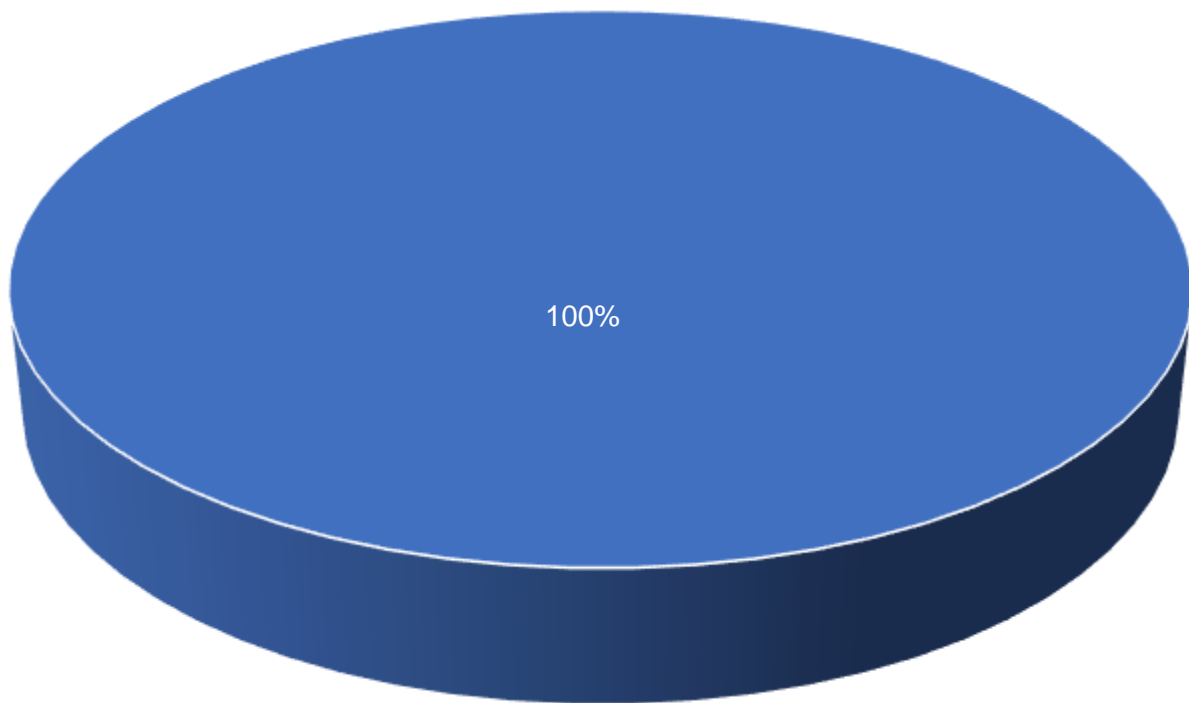

7. Would you come to future Consolidated Plan meetings, and tell others?



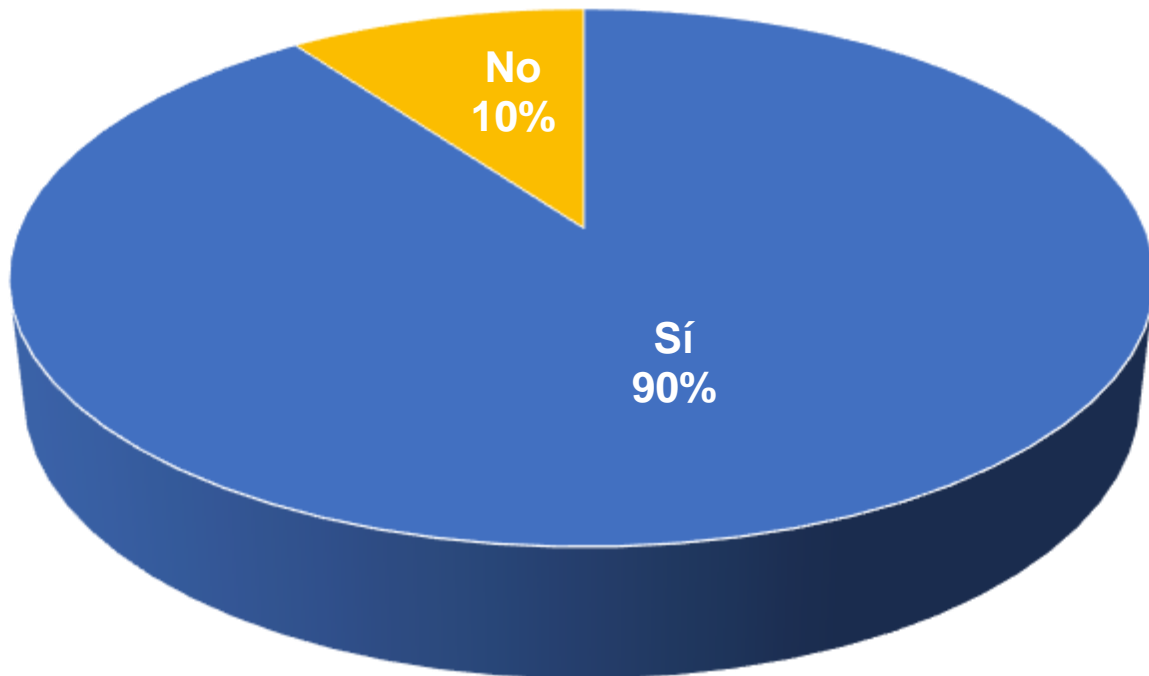
There were 19 responses out of 37 respondents; and 100% of them responded they would come to future Consolidated Plan meetings, and tell others.

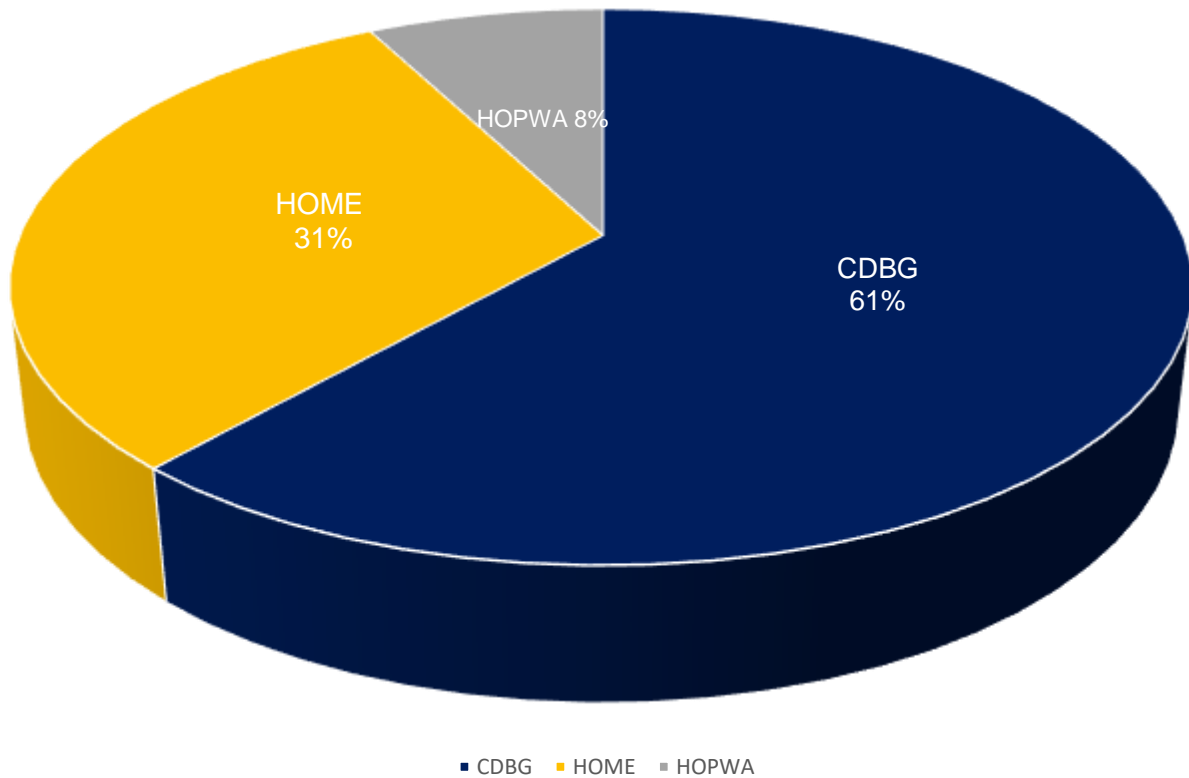

There were 10 responses out of 20 respondents, and 90% of those respondents attended the Consolidated Plan meeting for the first time.

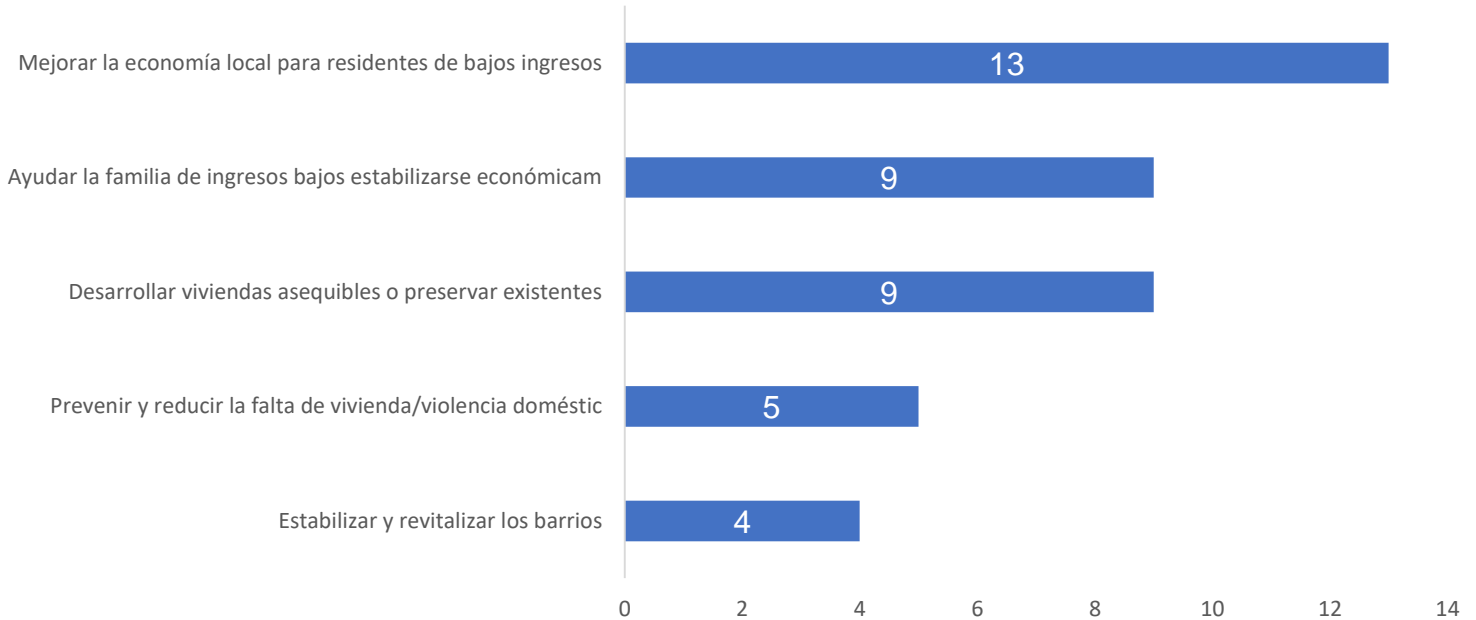


2. De las cuatro subvenciones federales mencionadas, ¿por cuál recibe la ciudad de Los Angeles más dinero?



There were 13 responses out of 20 respondents, and 61% responded correctly.

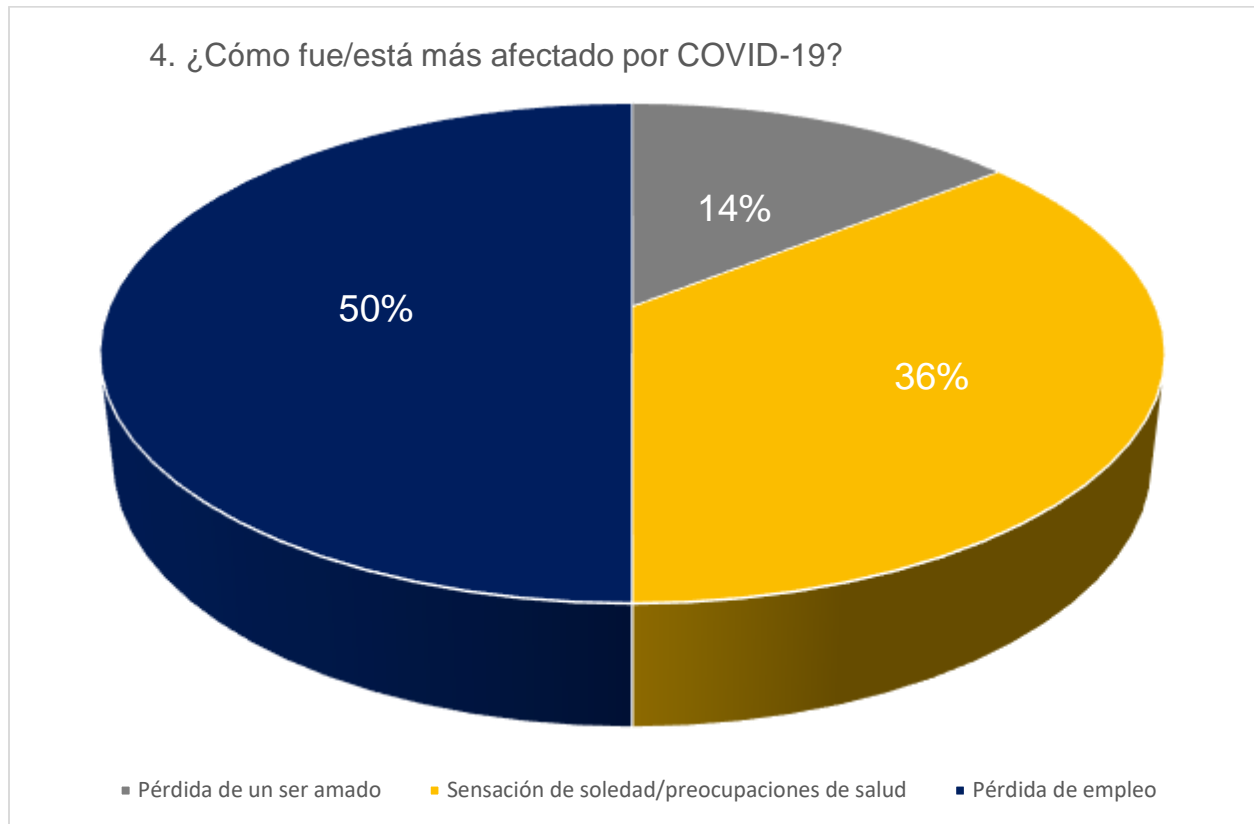
3. Ahora que han escuchado nuestras metas y visto ejemplos, ¿qué es lo más importante para ustedes? Elija solo las 3 mejores



The top 3 most important goals chosen were:

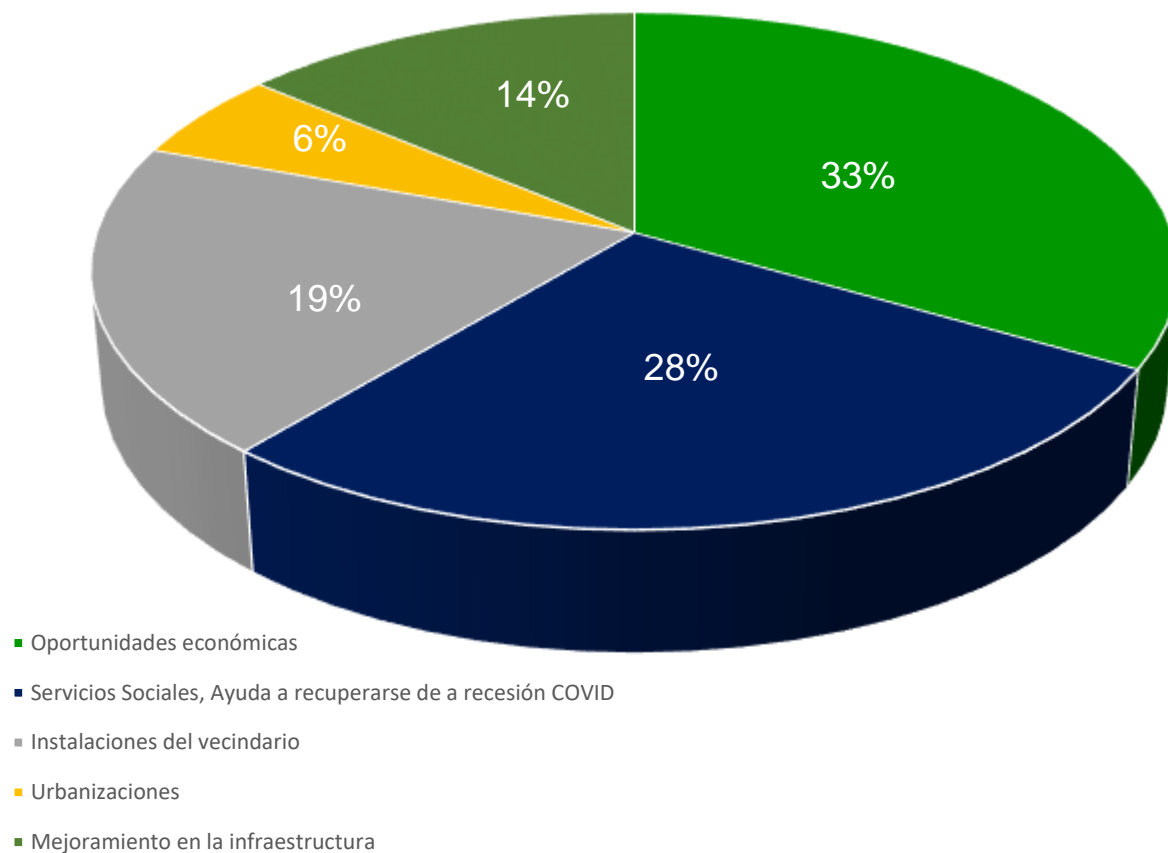
- Improving the local economy for low-income residents at 65%

## Commissioners' Questions/Comments

### **Los Angeles County Commission on HIV Planning, Priorities and Allocations Committee – October 20, 2020**

1. Q - How do the Con Plan grants work with the Ryan White HIV/AIDS program to address homelessness?

A - HCIDLA has a partnership with Los Angeles Homeless Services Authority (LAHSA) which is the lead agency to integrate and leverage other programs to address homelessness. This also includes short-term shelters, placing people in permanent supportive housing, the HOPWA (Housing Opportunities for People with AIDS) program and the whole range of housing needs. We are working on solidifying partnerships and building connections

2. Q - Are you looking for specific strategies for HOPWA?

A - Feedback does not have to be limited to HOPWA. The HOPWA program has a Request for Proposals out, and questions about how the program is being redesigned can be submitted to the RFP team.

3. Q - Are any cuts to HOPWA expected?

A - Cuts are not part of the latest funding information from the federal level. Current information indicates that next year's funding will mostly be level to this year. It's possible the HOPWA program may get an increase next year.

### **Commission on Community and Family Services (CCFS) – November 2, 2020**

1. Q - With potential staff reductions forthcoming, who oversees the maintenance, administration and tracking of the four grants?

A - The Consolidated Plan and Administration Section oversees the maintenance, administration and tracking of the four grants with an approximate staff of ten people. There are two units that work together, one that collects information from various sources to put the plan together, and another unit that looks at the details of each project to make sure they comply with federal regulations. At this time, we are unsure how the staff will be impacted by possible reductions.

2. Q - Are any of the staff members paid exclusively through Con Plan funds or a mix of HCID salaries. Is anybody dedicated to overseeing the use of these funds?

A –The people dedicated to overseeing the use of the funds include the ten people mentioned in the Consolidated Plan and Administration Section. The salaries of

those ten people are paid primarily with Con Plan funds. There is a percentage of the grant funding that can be used for administrative costs, and the Consolidated Plan Section is considered administrative. Throughout the Housing + Community Investment Department, approximately 200 staff members are either paid fully or partially from the Con Plan funds.

3. Q - With the influx of the big one-time grant, is there a timeliness associated with this grant or is there extra time to spend the funds? Is it a separate basket? Does it cover administrative costs?

A – In regards to the CARES (Coronavirus Aid, Relief, and Economic Security) Act funding, it is considered a separate basket. Each of the grants are treated differently and will have its own time period for performance. A portion can be used for administrative costs as determined by what the legislation allows. The three grants received from the CARES Act are being allocated to ensure maximum impact for the public, and discussions are still underway on how best to utilize the balance of funds, including the amount allocated for administration, with Council and Mayor approving the final amounts.

4. Q - With potential staff reductions, are the administration staff looking to fund bigger projects for the CARES Act funding, or is it up to whoever applies?

A – It is up to whoever applies, and the final decisions are made by the Mayor and City Council. Because of staffing concerns, that point is taken, and fewer and bigger projects would help if there are staff losses. It will be a consideration for recommendation to the decision makers.

Q – There was a backlog after the last round of furloughs, and CDBG was left in a bit of a wreck.

A – There were several things that factored in, and staff furloughs was one of the many factors that contributed to the City not meeting the CDBG timeliness standard several years ago.

5. Q – Regarding the tax preparations and earned income tax credit for families that was reported from the FamilySource Centers, what are other kinds of data that need to be reported and to whom?

A – Every year there is an annual performance report of data reported to HUD for each of the goals and what was accomplished. For each program, there may be other types of reports issued, such as to City Council, depending on each program's needs and requirements. For example, FamilySource also receives Community

Services Block Grant and may have other reports to a different federal agency to submit for that grant.

6. Q – Are there rolled-up outcomes reported to the public related to the Con Plan?

A – The annual performance report to HUD is a public report, and the report can be accessed by the public.

For the FamilySource Centers, HOPWA (Housing Opportunities for Persons with AIDS), Domestic Violence and Human Trafficking, Homelessness Prevention and Eviction Defense programs, HCID tracks and reports outcomes using a data system called Bitfocus Clarity. The data includes number of clients, demographics, services and outcomes.

7. Q – Regarding Project Roomkey, there is news about this program being a failure and being shut down. I was surprised to hear there is additional federal funding for this program.

A – The Homeless Services Manager can be invited to provide a separate presentation at the next commissioners' meeting on the Project Roomkey program to provide more information.

A - Many HCID staff worked as Disaster Service Workers at hotels for Project Roomkey and have some interesting stories of homeless persons not wanting to be housed inside or having concerns about their pets being left behind, etc. These are factors that may have impacted the number of persons served by the program.

A – (Homeless Services staff later joined the meeting and provided this clarification:) ESG CARES Act funds are to be used for rapid rehousing and interim housing which houses persons until they can enter more permanent housing. The funds are not for Project Roomkey.

A – We may have mistakenly indicated that CARES Act funding is allocated to Project Roomkey when it's actually proposed for Project Homekey, which is a program to obtain and rehab buildings to develop permanent housing solutions that would become available in the future, as people are moved into more permanent housing from the Roomkey program. The terminology was mixed up.

Note: The below questions followed the Con Plan update presentation on other matters affecting the current and coming program years.

8. Q - What is the procedure and eligibility for businesses applying for COVID-19 relief funds?

A - That program is operated by the Economic and Workforce Development Department and they are using other funds for that program, not the grants that were presented on today. We will find someone to answer that question.

9. Q - In the event of staffing disruption, how and when can the CCFS commissioners help the Consolidated Plan team with public engagement and grants allocation to support success in these efforts?

A – We are open and willing and interested in working more closely with the Commission, particularly when we have the next public meetings.

A - Other staff who work with the Commission described the different public engagement meetings and the time periods when these meetings are conducted, and the process of collecting information and supporting the City Council and Mayor who actually make the decision on how the funds are allocated.

Note: The Commissioners voted unanimously to have an Ad hoc committee to meet in between the quarterly meetings to assist the Consolidated Plan staff. The purpose of the committee is to ensure the Commissioners stay involved to advise on the Consolidated Plan for the current year and upcoming year, including how funding will be allocated and how to engage the public. The committee will exist for a six-month time period.

Following questions from the Commissioners, the public was provided an opportunity to speak, and no members of the public raised their hand to speak.
